The Advocacy Alliance has provided reliable and cost-effective Representative Payee Services for over 30 years and currently serves over 2,800 individuals who have mental illness or developmental disabilities, and older adults. We provide Representative Payee Services in Northeastern and South Central Pennsylvania, and the Poconos and Lehigh Valley, as well as in Allegheny, Philadelphia, and Westmoreland Counties. We assist individuals receiving Social Security Administration, Veterans Administration, Black Lung Act, and Railroad Retirement benefits, as well as pensions, annuities and earned income.

TRUSTED

We have contracts with County Mental Health/Developmental Disabilities Programs, County Area Agencies on Aging and Residential Services Providers, and can provide references from our contract sources upon request. Our Representative Payee Services are subject to regular review and oversight by an independent certified public accounting firm, as well as by the Social Security Administration and other governmental agencies. Our financial-management software, which was developed specifically for our program, allows us to comprehensively track individuals' finances and provide reports, very useful to contract sources and other appropriate parties.

FEE SCHEDULE

- Flat monthly fee of \$35 for Representative Payee Services (most often paid by individual receiving services)
- No up front fees or hidden costs
